Abstract The paper deals with the question whether cosmopolitanism is still a relevant concept for conflict resolution and peacebuilding. First, three common criticisms of cosmopolitanism are addressed, namely that it is Eurocentric, clitist and hegemonic. The paper concludes that these criticisms tend to focus on a limited liberal understanding of cosmopolitanism that does not do justice to the diversity of the concept. A redefinition and renarration of cosmopolitanism from a postcolonial standpoint is therefore necessary. Such a definition can only be an open minimal definition that leaves room for appropriation and localisation. This new, global perspective on cosmopolitanism is then evaluated against the background of conflict resolution in practice. The relevance of the concept becomes apparent when looking at the presence of clitist cosmopolitanism in the field.
